- Making reasonable adjustments where required on the job in collaboration with the HDNWA.
- Willingness to provide a testimonial following completion of a candidate's probation period.

## **Membership Category**

Applications for membership will be submitted to the Board for approval and notice of the Board's decision will be given in writing.

<b>Ordinary Member</b> – open to any organisation, corporation, partnership, company, sole trader, government department where their primary business is to provide hospitality and tourism services directly to individual consumers in WA; and where people are employed in the business to provide those services directly to consumers.
<b>Associate Member</b> - open to any organisation, corporation, partnership, company, sole trader, government department who are suppliers of any goods or services to business listed in the above Ordinary Member description.







#### **Terms**

Membership is for one year and is currently complimentary. The Board will review membership fees at the end of each financial year.

You will receive an invitation to the Annual General meeting held yearly to vote and can also nominate forward new board members.

One of the core benefits of attending HDNWA member events is the opportunity to network with other industry participants. An important condition of attendance at HDNWA events is that members do not use these events as an opportunity to market the services of their organisation to other members, or as a means to recruit members to join their organisation.

As HDNWA Inc are the recipient of a federal government grant to build employer confidence we may release information regarding your business name, size of organisation ABN and pay award, to the Department of Social Services.
